### Assumption of Risks

I understand that sports participation with Mallow United F.C. is a volunteer activity and carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. These risks include but are not limited to

- minor injuries such as scratches, bruises, and sprains
- major injuries such as fractures, internal injuries, joint or back injuries, heart attacks, and concussions
- catastrophic injuries including paralysis and death



I understand that Mallow United has advised me to seek the advice of my GP before participating in this activity.

I understand that Mallow United F.C. has a players personal injury insurance policy in place which offers limited cover to adult players who are registered as members of the club. I understand that this personal injury insurance policy has limitations and it is my responsibility to understand these limitations prior to participating in activities with the club. I have been advised by Mallow United that if I want personal injury cover that goes beyond the limitations of the policy purchased by the club then I should purchase my own personal injury insurance independently of the club.

I understand then no financial compensation will be made by Mallow United to any player other than compensation received upon completion of a successful claim through the insurance company providing the club's personal injury insurance policy for players. I understand that should I wish to claim for personal injury costs due to an injury obtained while participating in sports activities with Mallow United that my claim may take a number of weeks or months to process and I will not receive any financial compensation from the club in this intervening period.

I know, understand, and appreciate the risks that are inherent in participating in sport with Mallow United. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

## Financial Costs

### Annual Fees

#### Adult Membership (€20)

All players who train with an adult team must become an adult member of the club. This requires the player to complete an Adult Membership Application Form and pay the membership fee of €20. This will entitle the player to train with the adult teams and play in friendly fixtures.

#### Registration with Munster Senior League (€100)

To play with an adult team in a competitive fixture the player must be registered with the Munster Senior League. This requires the player to complete an Adult Membership Application Form and pay the membership fee of €20 (see above) and also complete a Munster Senior League registration form and pay an additional €80 registration fee.

### Weekly Fees

- Match day fee



- Each player is required to pay a fee of €5 for both home and away fixtures.
- Training fees
  - Each player is required to pay €2 per training session when training on grass and €5 per session when training on AstroTurf pitch.

**Fines**

As per Munster Senior League Policy all players with outstanding fines are suspended and cannot play for the club in a competitive fixture.
